

## 2020 Annual HEDIS®/Quality Rating System Reports

Blue Cross and Blue Shield of Texas (BCBSTX) has a Quality Improvement Program (QIP) to better serve you. QIP's purpose is to monitor and improve the care and service our members receive. We focus on encouraging preventive health and safety, and provide education related to chronic conditions.

Health Care Effectiveness Data and Information Set (HEDIS®) is a standard way to measure important areas of care and service. The HEDIS measures were developed by the National Committee for Quality Assurance (NCQA). They are widely used to measure health care performance in the United States.

The Centers for Medicare and Medicaid Services has a similar set of measures, the Quality Rating System (QRS). They measure similar areas of care and are specifically for those members enrolled in marketplace health care plans.

The table summarizes how BCBSTX is doing on selected measures.


Blue Essentials<sup>SM</sup> Demonstrated improvement in:

- Adult BMI Assessment 2.81 percentage point increase
- Childhood Immunization Combination 3 25.71 percentage point increase
- Breast Cancer Screening 2.83 percentage point increase
- Cervical Cancer Screening 0.20 percentage point increase
- Colorectal Cancer Screening 0.20 percentage point increase
- Medication Management for People with Asthma-Compliance 75% 8.35 percentage point increase
- HbA1c Control <8% 1.95 percentage point increase
- Eye Exam-Retinal or Dilated 0.81 percentage point increase
- Avoidance of Antibiotic Treatment in Adults with Acute Bronchitis 6.46 percentage point increase
- Postpartum Care 16.19 percentage point increase

Blue Advantage HMO<sup>SM</sup> (Retail) demonstrated improvement in:

- Adult BMI Assessment 1.25 percentage point increase
- Childhood Immunization Combination 3 10.23 percentage point increase
- Breast Cancer Screening 3.28 percentage point increase
- Cervical Cancer Screening 2.68 percentage point increase
- Colorectal Cancer Screening 2.18 percentage point increase
- Appropriate Testing for Children with Pharyngitis 2.21 percentage point increase
- Medication Management for People with Asthma-Compliance 75% 1.96 percentage point increase
- Hemoglobin A1c Testing 0.93 percentage point increase (from 2018)
- HbA1c Control <8% 2.19 percentage point increase
- Eye Exam-Retinal or Dilated 0.46 percentage point increase
- Appropriate Treatment for Children with Upper Respiratory Infections 2.85 percentage point increase
- Avoidance of Antibiotic Treatment in Adults with Acute Bronchitis 21.53 percentage point increase
- Postpartum Care 12.13 percentage point increase

QIP partnered with Network to develop a PCP Toolkit to promote the use of telehealth to encourage reaching out to members. A Childhood & Adolescent Access to Primary Care (CAP) letter and email campaign were developed to outreach providers to encourage them to use telehealth to complete the CAP visit.
