

## 2019 Annual HEDIS<sup>®</sup>/QRS Reports


Blue Cross and Blue Shield of Texas (BCBSTX) has a Quality Improvement Program (QIP) to better serve you. QIP's purpose is to monitor and improve the care and service our members receive. We focus on encouraging preventive health and safety and provide education related to chronic conditions.

Health Care Effectiveness Data and Information Set (HEDIS®) is a standard way to measure important areas of care and service. The HEDIS measures were developed by the National Committee for Quality Assurance (NCQA). They are widely used to measure health care performance in the United States.

The Centers for Medicare and Medicaid Services has a similar set of measures, the Quality Rating System (QRS). They measure similar areas of care and are specifically for those members enrolled in marketplace health care plans.

The table summarizes how BCBSTX is doing on selected measures.

## Key Accomplishments in Key Preventive 2019 Measures

Blue Essentials<sup>SM</sup> demonstrated improvement in:

- Adult BMI Assessment (5.15 increase over 2018 results)
- Avoidance of Antibiotic Treatment in Adults with Acute Bronchitis (1.06 increase over 2018 results)
- HbA1c <8% (7.75 increase over 2018 results)

Blue Advantage HMO<sup>SM</sup> (Retail) demonstrated improvement in:

- Adult BMI Assessment (83.33% is an 11.73 percentage point increase since 2017)
- Breast Cancer Screening (0.3% increase over 2018 results)
- Cervical Cancer Screening (6.32% increase over 2018 results)
- Colorectal Cancer Screening (48.18% is almost an 11-percentage point increase since 2017)
- HbA1c <8% (7.8 increase over 2018 results)
- Retinal Eye Exam (2.7% increase over 2018 results)

QIP has created HEDIS Tip Sheets related to Adult BMI Assessment, Comprehensive Diabetes Care and other measures. The HEDIS Tip Sheets are designed to assist you in improving the documentation of HEDIS measures. They will highlight understanding of the measures, what to document for compliance, what should be included in the medical record and the billing codes.
